Office Memorandum

As per approval of the Board of Directors of UJVNL in its meeting held on dated 23rd September 2021 "Performance Linked Incentive for the Financial Year 2019-20" shall be paid as under: -

- 1. The Performance Linked Incentive shall be paid to all officers/ employees of UJVNL working in the regular payscale including MD & all functional directors and employees working in UJVNL on deputation basis, subject to maximum of Rs. 25,000/- (Rupees Twenty Five Thousand Only) per employee. This will be distributed as under:-
 - (i) 50 percent of Rs. 25,000/- i.e. Rs. 12,500/- shall be paid equally.
 - (ii) The balance 50 percent of Rs. 25,000/- i.e. Rs. 12,500/- shall be distributed based on individual performance rating as under:-

Overall mark obtained in Performance Appraisal Report (PAR) for employees covered under KPIs	Confidential Report (ACR) by final authority for employees not covered under KPIs	Eligibility of Variable component of incentive
More than 90	Outstanding	1.0

- 2. The Performance Linked Incentive shall be paid to persons engaged through UPNL / PRD at the rate of Rs. 7500/- (Rupees Seven Thousand Five Hundred only) per person.
- 3. The Performance Linked Incentive shall be paid for actual days of attendance, paid holidays and casual leaves during the Financial Year 2019-20 on pro-rata basis. The other leave period will not be counted for incentive calculation.
- 4. The Performance Linked Incentive shall not be paid to employees having less than 50 rating points as per KPI in Performance Appraisal Report/ unsatisfactory evaluation in Annual Confidential Report.

- 5. The Performance Linked Incentive will only be paid to employees who have an unblemished record (no censor entry, no punishment, no suspension, no penalty etc.) during the Financial Year 2019-20. Employees dismissed / terminated from the service shall not be entitled for incentive. The employees against whom any departmental enquiry is pending as on date, his/ her Performance Linked Incentive shall be withheld and payment shall be subject to findings of enquiry.
- 6. The amount of Performance Linked Incentive for each eligible employee mentioned at point no 1 shall be calculated by the respective controlling officers / competent authorities on the basis of individual performance rating to be provided by HR Division, Dehradun.

The payment / fund transfer to units for Performance Linked Incentive to employees mentioned at points 1 and 2 above shall be released by CSPPO and CPO respectively on the basis of passed bills submitted by the respective controlling officers / competent authorities after ensuring compliance as mentioned above.
